BIOGRAPHICAL SKETCH:

In 1944 John Laurie contacted Ruth Gorman to ask her to explain the legalities of the Indian Act to members of the Indian Association of Alberta; in 1946 she agreed to act as their unpaid solicitor. Together with Ruth Gorman and members of the Hobbema Reserve, John Laurie worked to enfranchise Aboriginals to vote without losing their treaty rights. The fight for Aboriginal enfranchisement was commonly called the Hobbema case in newspapers since it was this reserve that brought the case to court. In the 1990's Ruth Gorman decided to write a book about John Laurie and his efforts in enfranchising Aboriginals. She was unable to complete the book; however, in 2002 the records were transferred to Frits Pannekoek who edited and published the *Behind the Man: John Laurie, Ruth Gorman and the Indian Vote* through the University of Calgary press in Calgary, Alberta.

CUSTODIAL HISTORY:

After Ruth Gorman's death, custody of the records was transferred to her daughter Linda Gorman who lent the records to Frits Pannekoek at the University of Calgary in Calgary, Alberta, until the records were donated the records to the Thomas A. Edge Archives & Special Collections and transferred to Athabasca, Alberta in 2008.

SCOPE AND CONTENT:

The series consists primarily of textual materials pertaining to Ruth Gorman's book about John Laurie and includes correspondence, newspaper and magazine articles about the

Hobbema case and Aboriginal issues in general and typed and handwritten drafts of the manuscript.

SOURCE OF TITLE: Title taken from contents of series.

DATE NOTE: Items dated after 2002 were created by Frits Pannekoek to edit and publish *Behind the Man: John Laurie, Ruth Gorman and the Indian Vote.*
